Winter Meeting Minutes February 12, 2017 4:30-6:30 Worthington Education Center

- I. **Welcome** Ally Minister began the meeting at 4:30 by thanking coaches for attending and for giving their time and energy to help grow lacrosse in Central Ohio.
- II. **Fall Meeting minutes** were approved. Thank you to Rachael Estepp for doing them.
- III. Proposed Bylaws- Ally gave a brief background of the bylaws and how they were modeled after those of the Ohio Schoolgirls Lacrosse Coaches Association. There weren't any questions or suggestions, and coaches voted to approve the bylaws.

VI. **5**th/**6**th **Grade Game Structure**- Bexley, Upper Arlington and Worthington will be playing smaller sided games (and some full field, depending on the opponent) and will provide feedback about this structure to the Association after season.

VII. Officials-

- **a. Rules:** Deb Welch and Bill Gardiner presented the USL Rules Interpretation and showed a video created by USL about the rules. The Youth Rulebook arrived by mail to all USL members in the latest Lacrosse Magazine, and can also be found online at www.uslacrosse.org
- **b.** Local Modifications:

The following are local modifications. All other USL rules apply. 1st/2nd

Time: A competition consists of two (2) twenty-minute running time halves, with a five minute halftime.

Timeouts: Each team can take two (2) two-minute timeouts during the game. The clock stops during this timeout.

Two-pass rule: There must be two passes initiated and received on the attack half of the field before a shot can be taken. A "received" pass is one that touches the head of the catcher's stick.

3rd/4th:

Time: A competition consists of two (2) twenty-minute running time halves, with a five minute halftime.

Timeouts: Each team can take two (2) two-minute timeouts during the game. The clock stops during this timeout.

Two-pass rule: There must be two passes initiated and received on the attack half of the field before a shot can be taken. A "received" pass is one that touches the head of the catcher's stick.

5th/6th:

Checking: there is no checking

Timeouts: Each team can take two (2) two-minute timeouts during the game. The clock stops during this timeout.

Carded player: when a player must leave the field because of a foul, a

substitute will take her place. **Modified pocket:** is allowed

- **c. Schedule:** Deb handed out a packet to each program that needs to be completed and mailed back by the March deadline. It includes a template for submitting your 5th/6th game schedule. Spectators should support players, and not be negative towards or try to instruct players. The host team is responsible for ensuring a safe, positive environment for games.
